Pioneer Pro Bond Crete 400 is a modified acrylic emulsion that has been formulated as a modifier for cementitious systems and a bonding and curing agent. It is resistant to hydrolysis and can be used for internal and external applications. It improves the application of plastering, assists in bonding cementitious topping, rendering and repairs mortar. It also improves adhesion when repairing cracked, damaged and spalled concrete.

Application Procedure

A. DIRECTIONS AS A BONDING AGENT

 Make sure that substrates to be treated are clean and free from contaminants. Smooth substrates must be mechanically roughened. Any existing steel



- reinforcement should be exposed and treated with Pioneer Pro Bond Crete 400.
- Pre-wet the substrate thoroughly to reduce moisture loss. Freestanding water should be removed.
- 3. Apply Pioneer Pro Bond Crete 400 by brush or roller.

B. DIRECTIONS FOR TOPPING AND PLASTERING

- Add Pioneer Pro Bond Crete 400 to cement plaster or concrete topping mixture.
- 2. Apply the mixture using steel trowel for plastering or topping application.

MIXING PROPORTION:

50 kilos ordinary Portland cement, 150 kilos sand, 4L Pioneer Pro Bond Crete 400, 10-12 L of clean water.

COVERAGE:

Approximately 6-8 square meters per liter as a bonding gent depending on substrate.

Packaging

4L-4 pcs per box

Storage

Cool, dry place; preferably 3°C maximum and away from direct sunlight.

Shelf Life:

6 months from manufacturing date.
